Chairman Harry Bell called the meeting to order. Mr. Carl Sloan made a motion to approve the minutes of the January 9<sup>th</sup> meeting, seconded by Mr. Jerry Mayes, approved 3-0.

No citizen comments.

Staff comments. City Manager Tim Ellis addressed the board regarding questions he's received about alcohol sales at events. Special events such as festivals and carnivals. City Manager Ellis explained the board didn't need to discuss this today but in the future the Beer Board and City Commission will need to discuss how to make decisions regarding these requests.

## New business.

Joyce Zhuo represented Fuji Steakhouse located at 801 Rivergate Parkway. Fuji Steakhouse is applying for an on-premises beer permit. Fuji Steakhouse will be open Monday through Friday 11:00 am – 9:30 pm. Weekends will be 11:00 am -10:30 pm. With no board or staff comments Mr. Mayes made a motion to approve the beer permit. Seconded by Mr. Sloan the board voted 3-0.

Lance Lester represented JPZ, LLC DBA: Silverado's Sports Bar and Grill located at 709 Rivergate Parkway. Silverado's is applying for an on-premises special event beer permit. Silverado's will host Bike Nights on Saturday afternoon's from 2:00 pm – 8:00 pm. Silverado's plans to have live entertainment, food on the grill and security checking ID's inside of a barrier fence for the event. Silverado's is changing this event from Wednesday evenings, in the past, to Saturday afternoons. Should the Saturday event not work for Silverado's they will need to come back before the board to have different dates approved. City Manager Ellis recommended that Mr. Lester make sure the Church that shares an adjoining easement with Silverado's also be notified about this event. Mr. Mayes made a motion to approve the special event beer permit. Seconded by Mr. Sloan the board voted 3-0.

Dupree Spiller represented Pinnacle Conference Drive, LLC DBA: Hampton Inn and Suites Goodlettsville/Nashville, located at 860 Conference Drive. Hampton Inn and Suites is requesting an

on-premises beer permit for their treat shop located to the right of the front desk. Mr. Spiller stated that since they are operating under The Hilton umbrella as Hampton Inn everyone is required to go through Alcohol Awareness Training. They are required to attend this all-day training within 30 days of their hire date. Mr. Mayes made a motion to approve the on-premises beer permit. Seconded by Mr. Sloan the board voted 3-0.

Eddie Anderson represented BeemPizza, LLC DBA: Long Hollow Pizza and Pub located at 900 Conference Drive, Suite 7B. Mr. Anderson explained they are a pizzeria that will serve Tennessee Craft Beer. He also stated they have another location Sanders Ferry Pizza and Pub in Hendersonville and they operate Swaney Swift's in Gallatin. Long Hollow Pizza and Pub will be open 7 days a week 11:00 am – 9:00 pm on weekdays and 11:00 am – 10:00 pm on weekends. Mr. Mayes made a motion to approve the on-premises beer permit. Seconded by Mr. Sloan the board voted 3-0. Mr. Sloan stated he really enjoyed eating at Sanders Ferry Pizza and Pub and complimented the way the did business. Mr. Anderson was appreciative.

Mr. Mayes made a motion to adjourn the meeting, seconded by Mr. Sloan the board voted 3-0. Meeting adjourned at 9:19.
